# 3. BRC Standardization (BRCS-TF)

She also shared the tentative checklist for ACM implementation guidance that helps to prepare the required documents based on the ISO 20387 chapter 7. A plan of a webinar for ACM members with a focus on BRC standardization has been announced.

## 4. Management of Material Transfer (MMT-TF)

Dr. Jung-Sook Lee summarized MMT-TF activities from 2006-2020 and reported the plan for MMT on the development of the model of contractual clauses of MAT/MTA. She also shared a few contractual clauses which are currently available and called for new members to join the activity. Lastly, Dr. Linhuan Wu introduced the discussion of DSI on genetic resources and the efforts in WDCM.

### • Closing Remarks

The ACM17 was closed with closing remarks made by Dr. Moriya Ohkuma from JCM. He expressed gratitude to all the participants and guest speakers, and concluded with hopes to meet face-to-face in Thailand next year.
