

# Background 1: Issues on accept deposition


As a public BRC of the government, we are expected to conduct lawful transfer of GRs.

# However, knowing ABS regulation of other countries is difficult.


# Background 2: Issues for country of origin




Under CBD & NP, deposition to an abroad BRC may become difficult as C. O. looses traceability and MTA- controllability.

C. O. may prefer to keep strains in the BRC of the country of origin and distribute to other countries.



HRD-TF (Human Resource Development) Confirmed possible collaboration for capacity building.


# Summary 1

Capacity building has been biased in science, but ADMINISTRATION is also very important as public BRC.


Share a good practice and bring back to home.


Develop collaboration by
